MEMORANDUM OF UNDERSTANDING

BETWEEN

Concordia University

Wisconsin

UNITED STATES OF AMERICA

AND

Keiai University

JAPAN

CONCORDIA UNIVERSITY (hereinafter CUW), 12800 Lake Shore Drive, Mequon, WI, 53097, USA, and KEIAI UNIVERSITY, 1-5-21 Anagawa, Inage-ku, Chiba City, Chiba JAPAN 263-8588 (hereinafter Keiai) wish to establish cooperative relations and agree to collaborate as follows:

AREAS OF COLLABORATION

Subject to the availability of funds and the approval of CUW and Keiai, collaboration will be undertaken through activities or programs, with exchange details to be agreed upon in further addenda, such as:

- 1. Exchange of students
- 2. Exchange of faculty members
- 3. Joint research activities
- 4. Joint educational programs
- 5. Exchange of academic and research materials

TERMS OF AGREEMENT

All terms and budgets for programs implemented under this agreement shall be mutually agreed upon in writing prior to program initiation. Programs must be approved individually by authorized individuals from each party.

Each participant shall designate a liaison officer to facilitate timely and accurate communications between the parties.

For the purposes of this Memorandum of Understanding and all further communications related to each specific program between CUW and Keiai, it is understood and agreed that neither party shall be liable for any negligent or wrongful acts, either of commission or omission, chargeable to the other, unless such liability is imposed by law. This agreement and all addenda shall not be construed as seeking to either enlarge or diminish any obligation or duty owed by one party to the other or to a third party.

RENEWAL, TERMINATION AND AMENDMENT

This agreement shall remain in force for a period of one (1) years from the date of the last signature, renewing automatically on that date, with the understanding that it may be terminated by either party giving thirty (30) days written notice to the partner institution.

This agreement may be amended with the consent of the two institutions through a written addendum executed by authorized individuals of both institutions. Such addenda, once approved by both institutions, will become part of this memorandum of agreement.

This MOU may be executed in counterpart and each counterpart is to read as an original document and all such counterparts are to be deemed as representing the same document. Signatures delivered by facsimile or other electronic means shall be deemed for all purposes to be original counterparts of this MOU. If this MOU is also being executed in one or more additional translations, the English version shall govern to the extent of any inconsistency among the translations.

This agreement shall be binding upon signing by authorized individuals of CUW and Keiai and shall be effective as of the date last written below.
